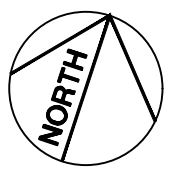
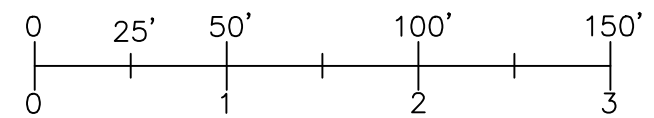


SITE LOCATION MAP
